This announcement is made by the Company pursuant to Rule 13.09 of the Listing Rules and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The Board wishes to inform the Shareholders and potential investors that on 14 March 2014, NCHI, HPSL and HISPL entered into the Termination and Transition Agreement pursuant to which NCHI, HPSL and HISPL have mutually agreed, among other things, to terminate the License Agreement and the S&M Agreement at midnight on 31 December 2014.

Upon the termination of the License Agreement and the S&M Agreement, HPSL will cease to provide NCHI with HPSL's relevant technology, experience and know-how of technical systems and operating standards and services to the Hotel as well as the license to use the name "Hyatt" in conjunction with hotel name, and related logos, trademarks, service marks and other relevant intellectual property rights, and HISPL will also cease to provide NCHI with the relevant sales and marketing services for the Hotel.

The Group is currently considering other hotel management companies in the market with a view to secure a hotel management company before the termination of the License Agreement and the S&M Agreement. The Company will make further announcement to update the Shareholders and potential investors as and when appropriate.

**Shareholders and potential investors are advised to exercise caution when dealing in the Shares.**
