On 30 April 2019 (after trading hours), Baltic Success Limited (the "Purchaser"), an indirect wholly-owned subsidiary of the Company, and each of Mr. Ng Kheng Teck and Mr. Wang Liduan, being the vendors (the "Vendors"), entered into the sale and purchase agreement, pursuant to which the Purchaser has agreed to acquire, and the Vendors have agreed to sell the entire issued share capital of Oriental-Invest Properties Limited at the total consideration of HK\$53,000,000 (the "Acquisition"). The consideration shall be settled by way of issue of the 5-year zero coupon convertible bond (the "Convertible Bond") in the aggregate principal amount of HK\$53,000,000 by the Company to the Vendors upon completion of the Acquisition.
